Julie Swafford, hence referred to as the Seller, and \_\_\_\_\_, hence referred to as the Buyer(s) hereby agree as follows:

The Seller hereby sells to the Buyer(s), for the amount of \$ \_\_\_\_\_ .00, payment which is hereby acknowledged, the AKC puppy registration #RN \_\_\_\_\_ puppy ID \_\_\_\_\_ whelped on \_\_\_\_\_ out of:

in accordance with the terms of this contract. This agreement is made and entered into on \_\_\_\_\_.

Seller guarantees that the above-described puppy is in good health at the time Buyer(s) assumes ownership. Buyer(s) agrees to have the puppy examined by a licensed Veterinarian within (5) days of receipt of puppy. If, as a result of the examination, the Veterinarian determines that the puppy is not in good health then the Buyer(s) shall elect to keep the puppy or return the puppy to the Seller for a refund. If the buyer elects to return the puppy, Buyer(s) shall, within 10 days after the date of the signing of this contract, send to Seller a written Veterinarian's certificate stating that the puppy was in ill health when examined. Upon receipt by Seller of said certificate, Buyer(s) shall be obligated to return the puppy to Sellers. Upon receipt of the puppy, the Seller shall be obligated to refund all monies received from Buyer(s) toward the purchase price of the puppy.

This contract is for the sale of a PET ONLY quality purebred AKC Miniature Schnauzer. The Buyer(s) agrees to have the puppy spayed/neutered before the puppy reaches one (1) year of age. If the Buyer(s) wishes to receive registration papers for the above said puppy from AKC the Buyer(s) agrees to supply a copy of a statement from the veterinarian stating that the spade/neutered surgery has been performed as agreed.

The Buyer(s) agrees to maintain reasonable medical care and shots for the puppy and into adulthood as long as the Buyer(s) retains ownership.

Buyer(s) agrees that ownership of the puppy may not be transferred to another person or person(s) without prior approval from the seller. The Buyer(s) also agrees to return the puppy to the Seller unconditionally in the event the Buyer(s) can no longer care for the puppy or adult dog.

The Seller agrees that the puppy shall have a 4-year health guarantee to be free from any congenital or inherited disease that severely affects the overall health of the puppy. Buyer(s) may return the puppy, in the event of any unforeseen congenital or inherited illness in exchange for a full refund of purchase price. Seller assumes no responsibility for medical expenses associated with the diagnosis or treatment of any congenital or inherited disease.

This Agreement is made and signed by both parties to insure the wellbeing and protection of this puppy. If the Buyer(s) breaches any part of this Agreement, the Seller is released from any obligations under this Agreement.
